EMPLOYMENT-RELATED COMPLAINTS

If you believe you have been discriminated against because of your race, color, sex (including sexual harassment), religion, age (if over 40), national origin, disability, marital status, sexual orientation, or reprisal for equal employment activities, in an employment matter or in the workplace, and wish to initiate an EEO complaint, then you must contact your EEO Counselor within 45 days of the alleged discriminatory action.
